

<Rules for Photography>

- For detailed information on facility usage, please contact us.
- Selling activities and distribution of flyers inside the building are prohibited.
- Please do not interfere with other users' activities.
- Distribution to friends is acceptable as long as it is not for commercial purposes, i.e., "selling." However, regarding self-published photo books, you are responsible for your actions.
- Please refrain from publishing photo books that include excessive exposure, sexual content, or photography that violates the law.
- Please do not include R18 content in self-published photo books. In case of any issues related to these photo books, we are not responsible.
- When displaying your work at the photo booth, please credit the following:

- You may not move furniture, decorations, or lighting without permission. In case of any damage or loss to the property, you may be held liable, so please be careful when using the facilities. If you notice any damage, please inform the staff immediately.
- Please refrain from actions that obstruct passage, loud voices, running, or other disruptive behaviors.
- Do not use the outlets on the premises for charging devices (e.g., cell phones, hair irons, camera batteries). Follow the facility usage rules.
- Changing clothes or applying makeup in restrooms or other nearby facilities is prohibited.
- Please do not cut wigs on the premises.
- Please manage your valuables and belongings on your own.
- We are not responsible for lost or stolen items or disputes between participants.
- Entry is prohibited for those who are intoxicated, engaging in public indecency, adult photography, obscene acts, disruptive behavior, or illegal activities.
- Photography is prohibited in restricted areas and near restrooms.
- Do not enter flower beds, climb trees, or damage flowers.
- Do not monopolize a photography spot for an extended period or reserve a spot by leaving your belongings.

<Costume Rules>

- Minimize skin exposure, and ensure underwear is not visible (including cases where underwear is visible through gaps around the chest or armpits).
- Overpants and underskirts are considered part of the costume.
- Costumes that expose underwear when bending over, such as short skirts, are prohibited. Please also wear stockings or tights with skirts.
- Costumes without underwear are prohibited.
- Nipple covers and silicone bras are considered underwear.
- Entry is not allowed for costumes resembling real public servants, security personnel, military uniforms, or those that violate public decency.

<Equipment Usage>

- Photography is limited to the photo booth. Otherwise, follow the facility usage rules.
- Only lighting equipment, tripods, reflectors, and strobes that do not require electrical outlets may be used. However, restrictions may be applied if it is deemed that they interfere with other participants.
- The size of reflectors, softboxes, umbrellas, etc., should be no more than 1 meter when fully extended.
- When using lighting equipment or tripods, cover the base with cloth or similar material.

<Props (Weapons, etc.)>

- The use of fake blood, knives, flammable materials, and other dangerous props is prohibited. For imitation swords, do not draw metal swords. Non-metal swords may be drawn only during photography but should be kept out of sight at all other times. Do not swing props or aim them at others.

1. Length:

- Avoid carrying weapons inside buildings. In the garden, weapons up to 1.6 meters are allowed.
- For larger weapons, ensure they can be disassembled and carried when not in use.

2. Carrying:

- When moving outside the building, the weapon must be in a non-drawable state (e.g., tied, in a bag, wrapped in cloth).
- Always carry weapons in a bag during transportation.

3. Model Guns:

- The use of firearms such as air guns, gas guns, or homemade guns is strictly prohibited. Please cooperate to ensure everyone's safety.
